

APPOINTMENT OF NON-PERMANENT TRUSTEES:

- That the founder President of the Trust in consultation with the other permanent trustees may appoint or nominate any number of non-(a) permanent trustees with a right to vote and holding office for one year, After the demise of the founder such power will vest with the permanent trustees to appoint and nominate non-permanent trustees.


